## Admissions Ceremony & Oath of Admission

Due to COVID-19, the mandatory admissions ceremony originally planned for June 1<sup>st</sup>, 2020 at Boettcher Hall has been canceled. In its place, the Office of Attorney Registration in conjunction with the Justices of the Colorado Supreme Court will host a number of remote admissions ceremonies in May to swear in cleared individuals in designated groups using Zoom. These smaller ceremonies are open to Feb 2020 exam applicants, on-motion applicants, as well as UBE score transfer applicants that are cleared to take the oath of admission.

We have implemented an electronic process to register for one of these remote admissions ceremonies. Therefore, we are not accepting walk-ins as we did in previous years. **Please do not come to our office to register for the ceremonies or to take the oath of admission in person.**

For individuals that have been cleared to take the oath of admission, please click the link below to register for one of the remote admission ceremonies. Once our office receives your completed submission (including online payment of fee by credit card), our office will confirm approval of your clearance to take the oath of admission and then provide by email an invitation with instructions to attend one of the smaller, remote ceremonies being held in May.

Also to accommodate all the candidates, we unfortunately are not able to extend additional invitations to family and friends to attend through Zoom. Therefore please do not forward your specific invitation for the smaller ceremony to anyone, as this is a unique login for just the approved individual. After each ceremony, our office will confirm attendance and activate licenses accordingly.
